- I-901 SEVIS FEE PAYMENT RECEIPT (Fee is paid after you receive I-20).
- COMPLETED MEDICAL HEALTH HISTORY FORM WITH PROOF OF VACCINATION.
- HEALTH AND LIFE INSURANCE VERIFICATION

Transfer Students must submit the following:

- A COMPLETED APPLICATION SUBMITTED TO ADMISSIONS
- A CERTIFIED TRANSLATED AND EVALUATED HIGH SCHOOL TRANSCRIPT VERIFYING COMPLETION STATUS AND A TRANSLATED AND EVALUATED TRANSCRIPT FROM EACH PREVIOUS COLLEGE ATTENDED OUTSIDE THE UNITED STATES. STUDENTS WHO HAVE ACHIEVED A MINIMUM OF A BACCALAUREATE DEGREE ARE ONLY REQUIRED TO SUBMIT A TRANSLATED AND EVALUATED TRANSCRIPT FROM THE DEGREE-GRANTING UNIVERSITY.
- ORIGINAL TRANSCRIPTS FROM ALL U.S. INSTITUTIONS ATTENDED
- AN AFFIDAVIT OF FINANCIAL SUPPORT (Also must include a bank letter in English and U.S. dollars indicating a minimum balance of \$22908.00)
- A COPY OF STUDENTS CURRENT FORM I-20
- A RECEIPT OF PAYMENT OF I-901 SEVIS FEE
- A COPY OF F-1 VISA AND VALID PASSPORT
- COMPLETED MEDICAL HEALTH HISTORY FORM (with proof of vaccination)
- HEALTH AND LIFE INSURANCE VERIFICATION
- COMPLETED I-20 TRANSFER FORM FROM TRANSFERRING COLLEGE VERIFYING THE STUDENT IS IN-STATUS
